 - 3. What are the Reserve accounts? They are one year of payments for each Bond Issue. Those funds will be held until the loan is paid off, per our Trust Indenture. Accounts are held by Regions Bank and managed by Trustee. Interest paid on these accounts eventually flow back to the operating fund.
 - **4.** Do the LNB CD's earn interest? Yes . . . currently 5.1% and is reinvested into the CD's.
