- **a.** Enrollment: October 1 enrollment 747, with 688 on-campus and 59 at NLWS. Current enrollment is 699, with 0 students at NLWS. 18 students are in alternative placement at home.

 - State initiative to increase the number of learning days in the school year
 - This year . . . 2 four-day sessions between 2^{nd} and 3^{rd} nine weeks and 3^{rd} and 4^{th} nine weeks
 - Opportunity for students to catch up if they are behind on coursework, not making sufficient progress or have absences to make up
 - Mandatory for 4th grade student that are not on reading level optional for other students
 - Allows student to "catch-up" during the year and before testing, as opposed to waiting until summer
 - This year is a test (ESSER funded) and we will determine whether to continue the program using general funds dollars in future years

I. New Business:

a. School Performance Score: We experienced a significant score and letter grade drop this year. Drop was due to a decrease in ACT scores and two data errors. First several errors regarding 12 students that transferred out of state and were counted as dropouts. Secondly, we misinterpreted how the Interests and Opportunities Index rules. Deadline for correction of data had passed before we learned of the erroneous data. State previously recalculated data when data was erroneous, but no longer will recalculate. Board members voiced several concerns and asked questions regarding the score decrease. Dr. Washington and Ms. Moss have worked with LDOE personnel to ensure accuracy of data for future reporting.

LEAP scores were much improved. K8 scores were up 11.4% (state average is 2.9%). High school scores are up 19.0% (state average is 3.2%). K8 progress scores are up 9.6% (state average is 2.0%). High school progress scores are up 5.1% (state average is 2.0%).
